Mark and Carla will provide key updates for HUD-CPD formula grant recipients. Specifically, the policy guidance will focus on the most frequently-requested areas of program management including emergency financial assistance, economic development and small business assistance, and documentation requirements to ensure cost eligibility and avoid duplication of benefits. # Twinning national and place-based practices: Elevating creativity and culture through community development approaches in place

Facilitators: Michelle Johnson, Senior Program Officer, Arts & Culture Program at the Kresge Foundation and Joi James, Fellow Detroit Program

Panelists: Bryce Detroit, Founder, Detroit Recordings Company, Raymond Lozano, Executive Director, Mexicantown Community Development Corporation, Christopher Robbins, CEO, American Riad, Reshounn Foster, American Riad and Karen Tyler Ruiz, Executive Director, Center for Community Based-Enterprise

Over the decades, we have seen approaches to development and planning further deepen and exacerbate structural inequities through strategies such as redlining and urban renewal. These tools created long-standing disinvestments and generated barriers to mobility for the most vulnerable in low-income communities that have disproportionately affected people of color.

This session will provide context and examples of how community development organizations are engaging with arts and culture practices to support equitable development approaches that center resident agency and shift power dynamics. These approaches incorporate resident history and culture into strategies of planning and development, creating more opportunities for equity and allowing for healing amongst those impacted. This body of work has become increasingly relevant as these organizations fight against the interwoven impacts of the pandemic and racial injustice.

Kresge Senior Program Officer, Michelle Johnson, and Fellow, Joi James, will host a conversation with grantees from the Kresge Innovative Project: Detroit (KIP:D) initiative. KIP:D supports nonprofits in their work to improve the quality of life and strengthen

the fabric of their local communities while advancing resident priorities through transformative projects that build on the assets and distinctive attributes of neighborhoods.

The Kresge Foundation's Detroit and National Arts & Culture Programs have partnered together to co-invest and blend national and place-based practices to support the mission of the Foundation: Expanding opportunities for low-income communities in America's cities. The initiative has provided over one million dollars to eleven creative placemaking projects across the city of Detroit thus far, as part of a broader investment of \$11 million in resident-led projects over the past six years.

### **Updated Michigan SHPO 106 Consultation Procedures**

The Michigan State Historic Preservation Office (SHPO), in an effort to better follow the federal regulations laid out in 36 CFR Part 800.11, made changes to the procedures for initiating Section 106 consultation in Michigan on July 1, 2020. This session will cover the changes, new procedures and forms involved in conducting the 106 process as it relates to federal CDBG & HOME projects moving forward.

### **Steps Toward Stepless: Making Housing Accessible**

Speaker: Thom Phillips, Michigan Branch Habitat for Humanity

According to the CDC, 61 million adults in the United States live with some type of disability. Nearly 14 percent of the population has a mobility disability, and the number of Americans using assistive technologies including wheelchairs continues to rise. As the need for accessible housing increases, simple design changes result in living space that is more usable by more people, regardless of ability or disability. These features allow owners and occupants to stay in their homes as their needs change without ever requiring major remodelling or modifications. Learn principles and methods to make homes inclusive, rather than exclusive, as well as ideas for making existing homes more usable to people living with physical challenges.


